## Complaints: U.S. Representatives

### Question

**Complaints:** U.S. Representatives

### Answer

The first step to filing a complaint against a Representative is sending the complaint to another Representative. The complaint must then be sent from this Representative to the [House Committee on Standards of Official Conduct](#). The Representative who files this complaint to the House Committee on Standards must state in writing that the complaint is being submitted for the purpose of initiating a Preliminary Inquiry. Once the House Committee has received the complaint they will initiate an inquiry into the complaint.

If the complaint has already been filed with a Representative, and he or she does not accept your complaint, you need to send it to another Representative for submission. If that Representative refuses to submit the complaint, you must contact a third Representative to submit the complaint to the House Committee on Standards of Official Conduct. You can only submit your complaint directly if the third Representative also refuses to submit your complaint. If you do so, your complaint must be made in writing and under oath to:

The complaint must be dated, and contain the following information in simple, concise, and direct terms:

- Name and legal address of the party filing the complaint;
- Name and position or title of the respondent (House member against whom the complaint is being filed);
- Nature of the alleged violation of the [Code of Official Conduct](#) or the law, rule or regulation; and
- Facts alleged to give rise to the violation.

Documents in your possession that relate to the allegations may be submitted with the complaint. You must also:

- Include legible copies of the Representatives' refusal letters to transmit the complaint to the House Committee on Standards of Official Conduct with your complaint.
- Clearly state the Representatives' refusal to transmit the complaint, and include the Representatives' acknowledgement that such refusal may cause the Committee to consider initiating a Preliminary Inquiry.
- Include a legible copy of the exact complaint submitted to, and considered by, each Representative. These must be attached to each Representative's refusal letter.
- Finally, the complaint must be accompanied by a certification that you have provided an exact copy of the complaint and all attachments to the respondent.

This complaint raises questions of election fraud in the 2008 presidential election. The details are presented below.

Examples, DCN1 and DCN2 are presented as evidence to support this complaint. These documents are part of the public record.

**Barack Obama refused throughout the vetting process to produce proof that he was a “natural born” citizen as required by the Constitution. On Obama’s word alone, Nancy Pelosi caused documents to be signed and distributed to forty nine of the fifty States hiding the fact Obama was not eligible for nomination or election.** Many others, including State DNC organizations, allowed the truth about Obama's eligibility to be hidden from the electorate and the public. The charge of fraud is now clearly a conspiracy of fraud against the electorate, public and the United States of America.

**TWO nomination documents were prepared. The second document [DNC2] included the “Constitutional” certification within the declaration:**

**The first [DNC1] document expressly excluded the “Constitutional” certification from the declaration:**

***THIS IS TO CERTIFY that at the National Convention of the Democrat Party of the United States of America, held in Denver, Colorado on August 25 though 28, 2008, the following were duly nominated as candidates of said Party for President and Vice President of the United***

*and nominated as candidates of said Party for President and Vice President of the United States respectively..*

Nancy Pelosi, the DNC and local State DNC Chapters filed the “non-Constitutional” certification document with the Election Commissions in forty-nine of the fifty States.

The two separate Nomination Certifications are complete with date stamps, matching signatures, even the same Notary of Public authentication.

As a result of the “Constitutional” Nomination Certification not being filed with forty-nine States the Election Commissions within these States were defrauded as the truth about Obama’s vetting and eligibility was purposely withheld, therefore misrepresented.

The 50th State, Hawaii, is a mystery as to why the DNC submitted the Constitutional Certification. It is assumed the State of Hawaii demanded the wording be included in the Certification. 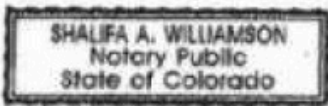
